Cemetery General Fund Revenues are estimated at \$33,800 and Expenditures at \$33,800. Sewer Operating Revenues are estimated at \$87,644 and Expenditures at \$49,538. Road Fund Revenues are estimated at \$203,914 and Expenditures at \$162,213. Second by Daniell Wolfe. Upon a roll call vote, the Act passed unanimously.
- Nicole Whitmore offered Resolutions to increase the Supervisor, Clerk, and Treasurer salaries to \$14,000 per year and keep the Trustee salaries at \$2,500 per year plus \$20 per meeting. Second by Danielle Wolfe. Upon a roll call vote, the resolutions passed unanimously.
- Nicole Whitmore moved to approve Budget amendments as presented by Clerk Heidi Drowley. Second by Danielle Wolfe. Motion carried.
- Nicole Whitmore moved to approve the following Gratiot County Road Commission contracts for 2025-2026:
  - Chloride contract for 4 full applications in the amount of \$71,084.32
  - Grave contract for 9.80 miles in the amount of \$87,612
  - Buchanan Road – Chip/Fog Seal in the amount of \$34,000
